Release, waive, discharge, and covenant not to sue SALT Educational Co-op, their committee members, employees, board members or other families participating in the Co-op (hereinafter referred to as "Releasees") from all liability to Family for any loss or damage and any claim or damage on account of injury to the person or property or resulting in death of a Family member while Family is participating in the Co-op activities or any other activities on the premises of Faith Bible Church.

Family agrees to indemnify Releasees from any loss, liability, damage or cost Releasees may incur due to the presence of Family in or on the premises of Faith Bible Church and realizes transportation to and from Co-op or any time off campus is the Family responsibility.

Family assumes full responsibility for and risk of bodily injury, death or property damage while in or on the premises of Faith Bible Church or while working or for any purpose participating in the activities of the Co-op.
